If you would like to purchase a new iMRS system after the return of the iMRS rental system, then a new system will be shipped to you separately after confirmation and payment of your order.

The iMRS Professional System comes with a full body mat, a pillow pad applicator and a probe for local applications. The three applicators will provide you with the full line of PEMF applications available. If you do not want to purchase a system, return the system (you pay for the shipping if required) after the trial period, at which time you will be refunded your full security deposit. **TWO WEEKS USING THE SYSTEM TWICE A DAY IS AMPLE TIME TO SEE RESULTS!**

Terms & Conditions

- The Sydney Myofascial Release Centre agrees to rent to the client, _____ the following system in accordance with the terms outlined below:
- The rental period is 2 weeks or 1 month subject to the terms below: ___ Paid \$330 + \$1,000 deposit
Rent: AUD \$330 (2 weeks) NETT, Security Deposit: AUD \$1,000
- Deposit and Rent to be paid up front.
- The Renter ensures that PEMF Therapy Australia property is protected against any theft, damage, destruction and/or premature wear and tear to The Sydney Myofascial Release Centres property during the rental period, until the Rental iMRS Complete System is satisfactorily returned to The Sydney Myofascial Release Centre.
- After the rental term, the Renter is obliged to return the system unconditionally to PEMF Therapy Australia within 7 business days from the return date above. Upon return, the rental system must be in the same condition as it was upon delivery. If the system is not returned in the same condition, The Sydney Myofascial Release Centre has the right to repair the system at the client's expense. The resulting costs will be deducted from the client's deposit.
- When the system is returned and inspected after the rental period, the Renter's deposit will be refunded in full within 3 business days. NB: The return form has to be filled out correctly and returned with the system.
- The Renter may purchase a new iMRS system after the rental period (2 above). A new system will be sent from Swiss Bionic Solutions upon payment and the rental system being returned. The deposit paid under the terms of the Rental Agreement will be returned (shipping not included). Maximum waiver of rental is up to 2 weeks (AUD \$300).
- All items and packaging shipped to the Renter as part of the iMRS Complete System ("Rental System") remains the property of The Sydney Myofascial Release Centre at all times during the rental period including transit times and cannot be sold.
- In the event that one of the clauses in this Rental Agreement is not complied with for any reason, all other clauses remain in force, and The Sydney Myofascial Release Centre and the Renter are obliged to find an acceptable solution so that the terms of this Rental Agreement can be enforced.
- In case of any changes or additions, a new Rental Agreement will be drawn up.
- In the event of a dispute, Australian law will apply.
- Renter agrees to pay all shipping costs if required, i.e. the cost to send the iMRS system to the renter and return it to The Sydney Myofascial Release Centre.
- Upon Default of Payment or Breach of Contract, an amount equal to the total purchase price (USD \$4,565), less any payments credited to Renter's account, is due and payable, and may be charged to Renter's credit card. If litigation is initiated, Renter agrees to pay for all legal fees, service fees, and interest as approved by the court.
- Renter acknowledges they have read, understand, and agree to all terms of this Rental Agreement.
